Questions/Comments:

Abe Villarreal, Student Government Advisor and Douglas Campus Dean, noted there is a decrease in the formation of student clubs and the goal is to help students feel confident enough to establish their own clubs. He also stated that the goal is to increase the number of clubs in order to appeal to different student interest.

1.05.4 College President

Dr. Rottweiler, President, complimented the SGA students for striving to increase student engagement, and noted that nationwide studies show that student success correlates with increased club/student activity participation. He then provided updates to the Governing Board; highlights include:

Legislative Update:

- As part of an RFP, AC4 conducted interviews with three firms for representation as the legislative liaison. High Ground with Nick Ponder and Scott Smith were selected, and a two-year contract was agreed upon. Nick has vast experience serving as the legislative liaison for the League of Cities and Towns. He understands the challenges of association representation with large and small organizations.
- The college is awaiting the November 5th election.
 - Federal Budget--\$850K for Douglas Campus Turf Projects
 - State-level races will decide control of the House and Senate
- Hosted candidates and officials from both political parties including:
 - Doug Ducy and Katie Hobbs
 - Two field hearings for the United States Congress
 - Mike Pence, Ron DeSantis, Robert Kennedy Jr., JD Vance, Donald Trump, and Vice President Kamala Harris.
 - During these visits, Cochise College continues to share a common message about the border, security, personal and commercial passage, and overall economic viability as a borderland's college.
- Dr. Rottweiler expressed his gratitude for the work the team has done over each
 of those visits. He has received numerous compliments about the facilities, the
 college, and most importantly, the people!
 - The recent visit by Vice President Harris was an example of the culture of excellence demonstrated daily at Cochise College. Dr. Rottweiler noted that while the Vice President's Campaign covered all cost associated with this visit, the college team truly rose to the occasion with dignity and grace and was able to meet the needs of the campaign.
 - The White House Communications Agency provided a special Certificate of Appreciation to Andrea Alston, Stella Rees, and David Luna. Dr. Rottweiler also recognized Dr. Jennifer Wantz and Dean Abe Villarreal for their hard work making the event a great success.

Facilities Update:

 All construction projects are on time and on budget. Plan is to take occupancy of the Fire Training Complex in late November with a Ribbon Cutting in December and plans to take occupancy of Bugen Hall in December with a Ribbon Cutting in January.

Questions/Comments:

Micayla Silas, current athletic student, spoke about the student-athlete experience, highlights include;

- Grew up in Wisconsin moved to Mesa, Arizona, then to Cochise
- Plays Guard position on the Cochise Women's Basketball team.
- Having Native American heritage, she was anxious to move away, but Cochise College has
 given her the opportunity to embrace and support her culture with family.

- Chose Cochise because of the people and the athletic programs at the college.
- During her time at the college, she was involved in a physical incident with teammate. She
 expressed her appreciation on how the situation was handled by the athletic director and
 the deans.

Department:

- Notification from the ACCAC on DI/DII scheduling split, which has created some challenges in terms of scheduling and budgets.
- CoolFM streams the men's and women's basketball games. This opportunity has given the teams more exposure and has created a more engaged community in terms of athletics
- November 15 & 16- Cochise Classic at Buena High School.
- This year, athletics have implemented the 2-2-2 initiative, which encourages student athletes to participate in 2 community service projects, 2 campus engagement project, and 2 department projects
- October 30- Athletics Presentation @ Buena HS
- January 22 Hosting Benson Night
- Mr. Falkner shared a phrase used often in athletics; "C.A.K.E." which stands for being
 coachable, accountable, kind, and engaged. The phrase serves as a reminder to the
 students that their behavior as a student athlete will help dictate his behavior as an athletic
 director and if they rise to the occasion and do what is expected of them, then it'll be "cake".

Mr. Falkner recognized the college's great athletic program. He also noted that having long-term coaches like Jerry Carrillo, Men's Basketball coach, and Todd Inglehart, Baseball coach, says a lot about the institution. Mr. Falkner also thanked several departments throughout the campus for their part in the success of the athletic department.

Questions/Comments:

Mrs. Strain inquired about how many student athletes; Mr. Faulkner responded noting there are about 120, which is up from 110 last year. He also noted that 24 student athletes were recognized as NJCAA Academic All-American (3.6 GPA or higher).

Dr. Rottweiler noted that having 120 student athletes is very robust, but that it plays a critical role in college operations.

Mr. Quinn noted that Micayla was a great spokes model and asked for an example of the 2x2x2 model. Mr. Falkner gave the example of cleaning, helping with Pit Fire, and supporting presentations such as the Native American presentation held last spring.

Questions/Comments

Mr. Hudgins and Mr. DiPeso congratulated Ms. Burnett for her hard work to turn the program around. Ms. Burnett recognized administration and her team for helping with their success.

Mr. Quinn asked how the leased aircrafts are going from a maintenance and logistics standpoint. Ms. Burnett responded stating they are working very well. Although, there are times mechanical maintenance issues arise, the leased airplanes are truly the core of the program. To help manage the maintenance issues, the program implemented maintenance checks every 15 hours of flight time instead of every 50 hours.

Mr. Quinn also questioned how the airfield facility is doing. Responding, Ms. Burnett states the runway and taxiway are in great condition with help from the Airport Pavement Preservation Project put on by Arizona Department of Transportation (ADOT). However, the ramp and parking area are struggling significantly. The pavement is deteriorating rapidly, but because of the type of pavement it is and where its located, it is not on the priority list for ADOT. The institution did receive a grant for the design, but there is a tear out component as well, which the college also received an ADOT grant for; however, it was agreed upon to not proceeded with the tear out until there is enough money to put the pavement back in, which could potentially be 2025 – 2026.

3.04 Douglas Campus Report

Abe Villarreal, Douglas Campus Dean, provided a presentation to the Governing Board regarding campus enrollment, housing and residence life, community engagement, and the Commercial Port of Entry; highlights include:

Enrollment:

- There are 33 classrooms being utilized with 234 course sections being offered for the full 16-week courses
- Many sections have caps lifted above 20
- ESL course offerings are at record high enrollment

Housing & Residence Life:

- New Director: Shane Van Bibber
- Weekly housing events; more than 40 have happened since July
- New AOC structure: includes a stronger leadership presence with event management
- 184 students and 16 staff in housing units.

Community Engagement:

- Weekly coffee networking hours from 8 a.m. to 9:30 a.m. on Fridays
- Weekly office hours at Mexican Consulate on Fridays from 2 p.m. to 4 p.m.
- Weekly radio spot
- Attendance at School Board Meetings, City Council meetings, local award assemblies, and graduation ceremonies.
- Tabling at community events
- Cochise en Espanol Zoom Sessions

Commercial Port of Entry:

- Cochise College is positioning itself to support the development of the new commercial
 port of entry and contribute to the region's economic growth. Leadership meets with city
 and county officials regularly as the port develops.
- Areas of educational training may include: construction and infrastructural development; logistics, technology, and cybersecurity; economic development and cross-border trade/entrepreneurship; public safety, health, and customs/regulatory compliance.
- Certificate and short-term training programs will be explored in partnership with government and private agencies.

Dean Villarreal also recognized Angie Bustamante and the TRiO program.

Questions/Comments:

Mr. Hudgins thanked Dean Villarreal for his efforts on the Douglas Campus.

Mr. DiPeso inquired about the rumors regarding the closing of the Douglas Campus; Abe noted that it is a rumor that has been around the community for a long time, even though it is not founded.

Mr. Quinn asked if there has been an increase in transborder students. Mr. Villarreal replied noting he does not have an exact number but it has increased. Currently there about 55 or more students who cross the border to come to class.

Mr. Quinn inquired about what type of certificates or short-term training are being discussed. Dr. Perey, Executive Vice President for Academics, responded noting that he and others contacted

Lightcast for economic forecasting asking what skills are needed to build and to support a port of entry. Unfortunately, they were not able to give the college any direction. However, the team has contacted the office of economic opportunity, who would like to work with the institution. From basic conversations with people from the Nogales Port of Entry, ideas for possible certificates or short-term training include international business trade as well as OHSA and other small skills training.

Dr. Rottweiler stated that so far it is unknown how this port will be used. Part of the planning is to have a larger entrance and exit on the commercial port for mining equipment. If this comes to fruition, Cochise County could become a fairly significant hub for heavy equipment repairs, which the college could then create programs to help meet the needs of the community. All in all, the port of entry will create new opportunities for the college, it is just a matter of waiting and seeing how it plays out.
