While Cochise College had an active archaeological excavation program, a number of human remains were added to the archaeological collection. In 1990, the Federal Government enacted the Native American Graves Protection and Repatriation Act, requiring the return of human remains to the tribal entities that claimed them. The process for doing so was developed over the next several years. That process has finally been completed, and the remains in the college's possession will now be repatriated to the Tohono O'odham for reburial.
