#### 2.01 Communications

#### 2.04 Revised Governing Board Policy 628 – Sick Leave

This revised policy is presented as a first-read for review and consideration. The proposed amendments reflect a change in the Sick Leave Payout procedure for employees hired on or after July 1, 2014. In addition, there are changes in formatting,

and language has been added to clarify accrual of sick leave will cease once the maximum accrual of 876 hours has been reached.

#### 2.05 Revised Governing Board Policy 629 – Personal Leave

This revised policy is presented as a first-read for review and consideration. The proposed policy increases Personal Leave for Faculty to sixteen (16) hours per fiscal year. Non-faculty will continue to receive eight (8) hours per fiscal year; however, the ability to convert 16 hours of Sick Leave to Personal Leave is removed. The proposed policy brings Personal Leave back to the original intent, which is to provide a leave benefit to Faculty.

#### 2.06 New Governing Board Policy 654 – Bereavement Leave

This new policy is presented as a first-read for review and consideration. The proposed policy is one of a number of leaves currently in Policy 633 – Special Leaves, being presented as a separate, stand-alone policy. This definition of family has been expanded beyond immediate family and proposes family be defined as a relative by the second degree, by blood or marriage, an established human resources industry best practice. As proposed, there is no longer the ability to use bereavement leave to attend services of a deceased colleague or the colleague's family member.

#### 2.07 New Governing Board Policy 655 – Jury Duty and Court Procedures

This new policy is presented as a first-read for review and consideration. The proposed policy is one of a number of leaves currently in Policy 633 – Special Leaves, being presented as a separate, stand-alone policy. This policy provides specific information on the expectations of an employee called to jury duty or if required to appear in court to testify in connection with a work related incident or private litigation, and is representative of Arizona State Statute requirements.

#### 2.08 New Governing Board Policy 656 – Leave Donation

This new policy is presented as a first-read for review and consideration. The proposed policy is one of a number of leaves currently in Policy 633 – Special Leaves, being presented as a separate, stand-alone policy. Language has been added to clarify all phases of this process. The maximum number of hours an employee can request be donated will be based on the same time frame associated with the Family and Medical Leave policy, a rolling 12 month period. An employee's eligibility to donate sick leave is proposed to be based on the number of hours they have accrued as opposed to being eligible for a "sick leave payout".

#### 2.09 New Governing Board Policy 657 – Military Leave

This new policy is presented as a first-read for review and consideration. The proposed policy is one of a number of leaves currently in Policy 633 – Special Leaves, being presented as a separate, stand-alone policy. This policy is consistent with State and Federal law, clarifies the years are "consecutive", specifies "benefited" employees will continue to be paid, and a copy of military orders is preferred, but not required.

#### 2.10 New Governing Board Policy 658 – Religious Observances

This new policy is presented as a first-read for review and consideration. The proposed policy is one of a number of leaves currently in Policy 633 – Special Leaves, being presented as a separate, stand-alone policy. Amendments are primarily to formatting and to designate this as an individual policy.

#### 2.11 New Governing Board Policy 659 – Voting Leave

This new policy is presented as a first-read for review and consideration. The proposed policy is one of a number of leaves currently in Policy 633 – Special Leaves, being presented as a separate, stand-alone policy. This policy aligns with Arizona State Statute and includes the requirement to request voting leave in advance.
