  Reading Instructor, Denisse Canez, accompanied two students to the March 2015
  HACU Capitol Forum held in Washington, DC. A report on their experiences at the forum will be provided.
- 2.02 Information Technology Update
  Carlos Cartagena, Vice President for Information Technology, will provide an update
  on technology-related projects and initiatives.
- 2.04 Revised Governing Board Policy 606 Nepotism
  Governing Board Policy 606 Nepotism, is presented as a first-read for review and consideration. The proposed amendments align all policies referencing "relatives", as defined by state statute, changes "spouse" to "legally recognized spouse", allows exceptions to this policy to be made at the discretion of the President, and includes a procedure for a "change in relationship".
- 2.05 New Governing Board Policy 617 Recruitment and Selection
  Governing Board Policy 617 Recruitment and Selection, is presented as a first-read for
  review and consideration. The proposed new policy reflects the migration from a paper
  based recruitment system to an online applicant tracking system. Current Policy 617 –
  Recruitment and Hiring Guidelines, attempts to cover a large volume of information
  resulting in a cumbersome policy making specifics difficult to locate. The proposed new
  policy aligns with practice and reduces the volume of information in one policy, moving
  information on Compensation Salary Placement and Classifications and Categories
  into stand-alone policies.
- 2.06 New Governing Board Policy 619 Compensation Salary Placement
  Governing Board Policy 619 Compensation Salary Placement, is presented as a
  first-read for review and consideration. The proposed new policy removes salary
  placement information from Policy 617 Recruitment and Hiring Guidelines and corrects
  the current policy which places new hires at a higher wage for minimum qualification
  experience as opposed to receiving a higher rate of pay for exceeding minimum

qualifications. The proposed new policy will aid in reducing the salary compression which had resulted in a number of current employees making less than new employees.

- 2.07 Revised Governing Board Policy 620 Salary Adjustments
  Governing Board Policy 620 Salary Adjustments, is presented as a first-read for review
  and consideration. The proposed revised policy aligns college salary and wage structure
  with current college practice. In addition, salary survey data sources have been
  updated.
- 2.08 Revised Governing Board Policy 636 Tuition Exemption
  Governing Board Policy 636 Tuition Exemption, is presented as a first-read for
  review and consideration. The proposed revised policy includes an exemption for
  online courses and removes information regarding Tuition Reimbursement, proposed
  to be in a stand-alone policy. In addition, part-time employee tuition exemption
  eligibility is limited to Associate Faculty having taught nine or more equated units and
  "regular" part-time employees working for a minimum of 15 hours per week for six or
  more months.
- 2.09 New Governing Board Policy 660 Background Screening Governing Board Policy 660 – Background Screening, is presented as a first-read for review and consideration. The proposed policy aligns with Equal Employment Opportunity Commission best practices and has been reviewed by the County Attorney.
- 2.10 New Governing Board Policy 661 Position Classifications and Categories Governing Board Policy 661 Position Classifications and Categories, is presented as a first-read for review and consideration. The proposed new policy facilitates locating this information and defines classifications and categories previously included in Policy 617 Recruitment and Hiring Guidelines.
- 2.11 New Governing Board Policy 665 Tuition Reimbursement
  Governing Board Policy 665 Tuition Reimbursement, is presented as a first-read for
  review and consideration. The proposed policy contains the majority of language
  previously included in Policy 636 Tuition Exemption and Reimbursement, but is a
  stand-alone policy and therefore presented as "new". The key amendment proposed
  requires an employee to complete one year of benefited employment prior to being
  eligible. General cleanup has also been performed.
- 2.12 New Governing Board Policy 666 Associate Faculty Load
  Governing Board Policy 666 Associate Faculty Load, is presented as a first-read for
  review and consideration. The proposed policy limits Associate Faculty to teaching
  fewer than 10 equated units per semester ensuring these faculty members will not
  qualify for health insurance under the Affordable Care Act.
