Mr. Quinn led the Pledge of Allegiance.

1.03 Adoption of Agenda

Mr. DiPeso asked about having student representation on the Board; Mr. White noted SGA members have representation on the Senate Committee, and he feels it could help the college to learn the needs of the students.

1.05.4 College President

Dr. Rottweiler provided the following updates to the Board:

Legislative Update:

- Provided a copy of the FY'2021 Budget request that was submitted to the Governor's Office on September 1. Based on increased FTSE, the college is showing a preliminary formula request increase of \$66,300 M&O and \$18,300 in STEM. Early Equalization formula runs have Cochise receiving \$622,400.
- The legislative agenda reinstatement of additional rural money as an ongoing formula amount; \$3.14M
- Provided a copy of the ATRA newsletter referencing an article on Colleges Big Winner in State Budget
- Prop 301 Initiatives potentially to be placed on the ballot
 - Helios initiative would increase the sales tax to provide over a billion dollars to education; with \$100M for community colleges to reinstate money lost in 2008
 - Invest in Ed initiative voter initiative that is a vote of the citizens; community colleges hopeful the two initiatives can be put together
- Smart and Safe Arizona Act (marijuana legalization act) gatering signatures
 - \$100M for community colleges
 - unsolicited by community colleges with no quid pro quo expected; revenue going to:
 - Community policing, treatment, mental health, etc.
 - AC4 Meeting on September 25 and 26 to continue legislative agenda

Master Facilities:

- Student Union Remodel
 - August 28th ribbon cutting
 - Represented by Mr. Hudgins and Mrs. Strain
 - Alumni and community leaders
- ART/FAB Construction is complete, except Kiln Yard
 - o Electric kilns ready to use
 - o Gas kilns waiting on parts
 - ribbon cutting/open house during Pit Fire on Oct 4
- Greenhouse for Agriculture
 - o Pad completed within the week
 - o Utilities will be run in the coming weeks
 - o Building bids closes on the September 17
- Automotive Technology Building
 - Waiting on value engineering
 - Will need to add resources to the anticipated construction costs
 - Guaranteed Maximum Price (GMP) delivered soon and may require a special meeting to approve
 - o Utilize some of the \$3.14M additional funds from the state.

New Initiatives:

- Governing Board suggested Initiatives this fiscal year include:
 - Douglas Administrator discussions will be finalized over the next couple of weeks with a job posting to follow.
 - Anticipate a January start date
 - Solar Trough Repair a purchase request issued for Pueblo Mechanical to conduct an Engineering Analysis of the entire Central Plant System on the Douglas Campus.
 - Repair costs will be included in either this year's repair or next fiscal year's budget, depending on the recommended expenses.
 - Health-Related Programs academics tasked with providing a feasibility study for future health-related programs. The addition of programs will go through the academic stage gate and budget process.

Questions/Comments:

Mrs. Strain inquired about the slight increase in FTSE enrollment; in response, Dr. Rottweiler noted the percentage is small but the fact that FTSE rates remain relatively flat in times when the graduating student rates are declining, is good for the college. The downfall with the population decreasing is that the funding formula is based on enrollment, so as enrollment decreases, so will state funding.

 - Recognized the day as World Suicide Prevention Day, and he thanked the college staff for engaged leadership, fellowship, and friendship with all of the students. Also noting the greatest risk to 15-24-year-olds are themselves. Continue to reach out to students and engage them in a discussion.
 - Cochise College makes a difference for students from the ones going on to a four-year university or the student who has turned their life around because of a college program.
