2. NEW BUSINESS ACTION

2.01 College Operations – Fall 2020

Following a Governing Board Work Session held on July 24, 2020, the administration recommended the Governing Board adopt a motion authorizing the College President to move all instruction, except in those cases where in-person instruction is required, to a remote format for fall 2020. Dr. Rottweiler updated the board noting the college had received notification from the Trust saying that they believe they have found a solution to provide liability coverage. They will present it to the Trust Board for approval on August 4.

The college has received no response from the Arizona Governor's office in response to a letter submitted from the Arizona Community College Coordinating Council. The United States Senate has proposed a \$1T HEALS Act, which includes a liability shield that would prevent businesses, Universities, school, and hospitals from being sued over Coronavirus without proof of both gross negligence and a violation of state and local public health guidelines.

Mr. Quinn moved, and Mr. DiPeso seconded a motion authorizing the College President to move all instruction, except in those cases where in-person instruction is required, to a remote format for fall 2020. Mr. Quinn questioned ensuring faculty and staff follow the safety guidelines such as wearing masks in the face-to-face classes; in response, Dr. Rottweiler said the administration has created policies and will continue to educate and oversee compliance through risk management. The Governing Board unanimously approved with members, David DiPeso, Don Hudgins, Dennis Nelson, Tim Quinn, and Jane Strain all voting aye. MOTION CARRIED
